#### **PROCEDURES**

### Issue of new firefighting torch

#### Who needs to read this?

All firefighters.

#### Rescindments

This document rescinds:

- In Order 1989/6 Torches and portable lighting
- In Order 1994/17 New torch for use with BA equipment

#### **Background**

The Streamlight Knucklehead torch (torch) is being individually issued to firefighters.

The torch features:

- rotating, articulating head
- tough, polycarbonate lens
- four lighting modes: high, low, flashing and moonlight
- magnet (removable) which allows stable scene lighting.

The torch replaces the Wolflite, Super Sabrelight issued with BA sets, and torches generally issued for use in vehicles. It does not replace specialised torches such as those issued to heavy hazmat appliances, heavy rescue appliances and USAR.

Wolflite torches will not be removed from appliances. However they will not be repaired, replaced, or installed on new appliances. Wolflite torches may be used while they are still operational.

Individually purchased torches must no longer be used at incidents.

The new torch is being issued to you personally. It is no longer part of the self-contained breathing apparatus (SCBA) and will not be tracked with SCBA.

#### When to use the torch

Use the torch in conjunction with SCBA or structural firefighting ensemble, and for personal lighting at incidents as required. Stow the torch in your PPE kit bag.

#### **Delivery of new torches**

Your Zone Commander or supervisor will issue you with your new torch. Issue will commence in July 2015 and is expected to be complete by end August 2015.

**On delivery:** Mark your name on the torch with a permanent marker. Do not engrave the torch as this may compromise the integrity of the torch.

#### Return of torches on exit from duty

When you leave FRNSW, you must return your Streamlight torch to your Station Commander or supervisor. Station Commanders should then forward torches to the Zone Office. Return of the torch must be documented on the Exit checklist.

#### Disposal of the old torch

Once all firefighters have received their new torch, instructions will be issued for disposal of old torches. Old torches should be kept in the station until these disposal instructions are received.

#### **Procedure documents**

These documents must be read by everybody before they use the new torch.

- SIMS worksheet, <u>Personal protective equipment: Firefighting and duty wear</u> (Version 04) on the <u>SIMS equipment worksheets</u> toolkit.
