#### **PROCEDURES**

## **Correctional facility incidents**

Firefighters may be called to attend a correctional facility as part of their duties. These facilities pose unique hazards for firefighters and have required levels of security under which FRNSW must operate.

#### **Key points**

SOG 8.3 has been reviewed and updated to include:

Current Corrective Services NSW procedures and terminology.

Updated guidelines for assessing risk and managing incidents at correctional facilities.

Instructions that can be applied at detention centres.

SOG 8.13 has had a minor amendment to update FRNSW terminology and remove old references.

#### What needs to be done?

Station Commanders must ensure that all crews are aware of the contents of the SOG. All operational staff must sign off the SOGs in the Station Planning System (SPS) for station staff or Employee Self Service (ESS) for operational staff not attached to a station.
