Public Interest Disclosures Policy and Procedures

The revised <u>Public Interest Disclosures Policy and Procedures</u> has been published on the Conduct toolkit on the intranet.

Key points

The purpose of this policy is to inform all staff of the new protections provided to public officials who report serious wrongdoing under the new *Public Interest Disclosures Act 2022*, in effect from 1 October 2023. The legislative changes have been included in the revised policy which includes that all people leaders may receive and appropriately manage Public Interest Disclosures in the workplace.

Records Management Policy Update

The Records Management Policy has been published on the <u>Information and Records</u> Management toolkit on the intranet.

Key Points

The purpose of the Records Management Policy is to guide staff, including firefighters, administrative and trades staff, volunteers, contractors, consultants, and skill hire staff (contingent labour hire - administrative staff), to achieve recordkeeping compliance. Recordkeeping compliance is when full and accurate records of all activities and decisions of Fire and Rescue NSW (FRNSW) are created, managed, and retained or disposed of using the correct retention and disposal guidelines.

Section 7.1 Clear Desk and Lock PC/Laptop Practice
