## PROCEDURE

### Response of additional appliances from stations

The procedure for [Response of additional appliances from stations](#) has been published on the [Administration Policies page](#) of the Intranet.

#### Key points

- This procedure sets out the circumstances in which Station Commanders have the discretion to respond additional appliances from stations, and the procedures that must be followed when this happens.
- This procedure has been revised to give Station Commanders the discretion to respond a hazmat pumper with a heavy hazmat appliance.
- Station Commanders must notify the Communication Centre if they respond additional appliances.

#### Who needs to read this policy?

This instruction needs to be read by Station Commanders of stations with more than one appliance, Zone management teams and Operational Communications staff.


