## Meal, travelling and other allowances

The Public Sector Industrial Relations (PSIR) Circular 2013-07, <u>Review of Meal, Travelling and Other Allowances</u>, issued on 25 September 2013 informs the public sector that certain allowances have been reviewed and adjusted in the *Crown Employees (Public Service Conditions of Employment) Award 2009*.

Accordingly, meal and refreshment allowances have been adjusted from 1 July 2013 in line with the Australian Taxation Office, Taxation Determination (TD 2013/16), which sets out the reasonable allowance amounts for the 2013-14 financial year.

The meal, travelling and related allowances contained in the following awards have accordingly been varied:

- Crown Employees (Fire and Rescue NSW Permanent Firefighting Staff) Award 2011.
- Crown Employees (Fire and Rescue NSW Retained Firefighting Staff) Award 2011.
- Crown Employees (Public Service Conditions of Employment) Award 2009.

The new rates apply to Firefighters and Administration staff from 1 July 2013. Please note the amended rates and appropriate back payments will be made for meal, travel and other related allowance claims arising on and from 1 July 2013 in pay period 17 October 2013.
