#### **Inspectors Promotional Program Pre-entry Test**

This instruction rescinds Commissioner's Orders 2013/15, *Inspectors Promotional Program Pre-entry Test*.

An Inspectors Promotional Program (IPP) will be held in 2013 to fill vacant and projected Duty Commander positions.

The 2013 IPP's Pre-entry Test will be conducted pursuant to IRC Matter Numbers 461 and 615 of 2013 in accordance with the *Inspectors Promotional Program Pre-entry Test* procedure published on the <u>Administration Policies</u> page of the Intranet.

#### **Positions Available**

There will be 14 positions available on the 2013 IPP. Five of the 14 positions will be Country Inspector positions, 4 of which have already been allocated to candidates from the 2012 Preentry Test's order of merit list.

The order of merit for the remaining 2013 IPP positions will be determined by the level of achievement of applicants in this year's Pre-entry Test.

**Note**: Country Inspector positions are subject to the provisions of <u>In Orders 2006/2</u>, *Guidelines for the allocation of unfilled Country Station Officer and Inspector positions*.

The closing date for Portfolio submissions is 1700hrs on Friday 6 September 2013.
