PROCEDURES

Recommended practice – Personal flotation device: Crewfit 275N

Recommended practice, *Personal flotation device: Crewfit 275N* (Ver 01) has been published in the Recommended practices toolkit on the FRNSW intranet. The related SIMS worksheet has been published on the SIMS equipment worksheet toolkit.

This recommended practice guides operators in the correct use and maintenance of the Crewfit 275N personal flotation device (PFD), or lifejacket, which is being trialled for use when a body of water presents a drowning hazard to firefighters. The PFD has a fire resistant cover, a deck harness for restraint, and a buoyancy of 275.

Station Commanders with this equipment installed on their appliance should download the SIMS worksheet and add it to the SIMS board.
