Fire & Rescue NSW's revised Fraud and Corruption Policy and Prevention Control Plan

Fire & Rescue NSW (FRNSW) is committed to the highest standards of ethical conduct and strictly prohibits fraudulent behaviour, corrupt conduct and other forms of wrongdoing.

FRNSW's revised *Fraud and Corruption Policy* defines what constitutes fraudulent and corrupt conduct, why it occurs and outlines the responsibilities of employees in identifying and reporting such conduct.

This policy also incorporates a *Prevention Control Plan* which details FRNSW's integrated approach to preventing, detecting and reporting on fraud and corruption exposure at strategic and operational levels throughout the organisation.

This revised policy replaces our current version, which was published back in 2009.
