NOTICES

Heavy vehicle registration labels no longer required

Prior to 1st July 2018 it was a regulatory requirement that heavy vehicles display a registration label. It was also a driver offence to drive a heavy vehicle that was not displaying a current registration label.

As of the 1st July 2018, the regulatory requirement that heavy vehicles display a registration label was repealed, as well as the associated offence of driving a heavy vehicle not displaying a registration label.

In the past the Fleet Management Unit sent the new registration label to the station with a request that the label be affixed to the vehicle. This will no longer occur as Roads and Maritime Service will no longer be providing registration labels as part of the certificate of registration. The existing registration label should be removed.

The Fleet Management Unit will continue to ensure the vehicle is inspected and registered at the appropriate time.
