## PROCEDURES

## **Recommended Practices**

The Recommended Practice – <u>Personal Protective Clothing, Equipment and Uniform</u> has been amended to include safety warnings to remove IMS tabards from use on or near roadways.

The new version 3.2, has been revised and published on the <u>Recommended Practices -</u> <u>Equipment</u> listing on the intranet.

#### Key points

- Incident Management System (IMS) red tabards are no longer compliant with AS/NZS 1906.4:2010 for high-visibility materials for safety garments used for road traffic control.
- The removal of IMS tabards from use on or near roads in the Recommended Practice is an interim measure, pending a full review of the use of tabards in the IMS and identification of a new specification for compliant IMS tabards.
- A project plan is being developed for a full review of the Recommended Practice within six months.

#### Who needs to read the revised document?

All staff, particularly those involved in the use of IMS tabards and Incident Management System, should read the updated changes on pages 8,17 and 45 of the Recommended Practice.

#### Rescindment

This plan rescinds Recommended Practice – Personal Protective Clothing, Equipment and Uniform, Version 3.1 (Sept 2015).
